## **Main Points**

# • Firearms means any lethal barrelled weapon of any description from which any shot, bullet or other missile can be discharged, or which can be adapted for the discharge of any such shot, bullet or other missile.

- Ministry of Home Affairs (KDN) is responsible for ensuring the possession of firearms are monitored, controlled and guided according to the law in terms of usage, storage and safety.
- The auditing compasses two main areas namely activity performance and activity management for Firearms Management and Supervision for Department and Agencies under KDN for the period from 2019 to 2022. The activity performance is based on output achievement and outcome achievement. Activity management covers management in handling and licensing of firearms.

### Why it is important to audit? To assess whether the management and supervision of firearms have been carried out economically, efficiently and effectively to ensure that firearms is monitored, controlled and regulated according to the law in terms of usage, storage, and safety.

**Conclusion** Overall, the management and supervision of firearms in the departments and agencies under KDN are less satisfactory. There are weaknesses in the formulation of policies regarding the norms of firearms and ammunition and there have been cases of lost firearms belonging to the departments and agencies under KDN. In addition, there are weaknesses in the enforcement of the Arms Act 1960 for the renewal of firearms licenses which affect the control of firearms by PDRM. Inefficiency in procurement management has resulted in an estimated loss of RM6.34

million to the government and weaknesses in the firearms disposal management can have an impact on security risks.
